With these new additions, How to Read a Dress, revised edition, presents a complete and up-to-date picture of 'the dress' in all its forms, across the centuries, and taking into account different sartorial and social experiences. Sacred stimulus offers a thorough exploration of Jerusalem's role in the formation and formulation of Christian art in Rome during the fourth and fifth centuries. The visual vocabulary discussed by Galit Noga-Banai gives an alternative access point to the mnemonic efforts conceived while Rome converted to Christianity: not in comparison to pagan art in Rome, not as reflecting the struggle with the emergence of New Rome in the East (Constantinople), but rather as visual expressions of the confrontation with earthly Jerusalem and its holy places. After all, Jerusalem is where the formative events of Christianity occurred and were memorialized. Sacred stimulus argues that, already in the second half of the fourth century, Rome constructed its own set of holy sites and foundational myths, while expropriating for its own use some of Jerusalem's sacred relics, legends, and sites. Relying upon well-known and central works of art, including mosaic decoration, sarcophagi, wall paintings, portable art, and architecture, Noga-Banai exposes the omnipresence of Jerusalem and its position in the genesis of Christian art in Rome. Noga-Banai's consideration of earthly Jerusalem as a conception that Rome used, or had to take into account, in constructing its own new Christian ideological and cultural topography of the past, sheds light on connections and analogies that have not necessarily been preserved in the written evidence, and offers solutions to long-standing questions regarding specific motifs and scenes.

There are now more single adults than married adults in the United States, yet the evangelical church continues to focus primarily on serving couples and families with children rather than single people. This can lead, however unintentionally, to the marginalization of adults who are single by choice, divorce, or death, or who are simply not yet married. Families are a good thing, but so are all of God's people, and singles long to be lovingly integrated into the Body of Christ. In One by One, Gina Dall'ozzo explores common misconceptions and stereotypes about singles, including the idea that they must be single because something is wrong with them, and the subtle (and not-so-subtle) ways they are devalued, like when sermons focus overmuch on navigating marital relationships or raising children. She shows how the church of Paul, who commended those who remained single, became the church where singles are too often treated like second class Christians. Then she explores what the church is doing right, what unique services singles can offer the church, and, most importantly, what the church can do to love and support the singles in their midst.

***In his most recent work, the contemporary philosopher Roger Scruton has turned his attention to religion. Although a religious sensibility ties together his astonishingly prodigious and dynamic output as a philosopher, poet and composer, his recent exploration of religious and theological themes from a philosophical point of view has excited a fresh response from scholars. This collection of writings addresses Scruton's challenging and subtle philosophy of religion for the first time. The volume includes contributions from those who specialize in the philosophy of religion, the history of thought and culture, aesthetics, and church history. The collection is introduced by Mark Dooley, author of two books on Scruton, and includes a response to the writings from Scruton himself in which he develops his idea of the sacred and the erotic and defends the integrity of his work as an attempt to give a sense of the Lebenswelt (or 'lifeworld'): how humans experience the world. He argues that religion emerges from that experience and transforms us from beings bound by causal necessity into persons who acknowledge freedom, obligation and right. ***Fueled by grassroots activism and a growing collection of formal political organizations, the Christian Right became an enormously influential force in American law and politics in the 1980s and 90s. While this vocal and visible political movement has long voiced grave concerns about the Supreme Court and cases such as Roe v. Wade, they weren't able to effectively enter the courtroom in a serious and sustained way until recently. During the pivot from the 20th to the 21st century, a small constellation of high-profile Christian Right leaders began to address this imbalance by investing in an array of institutions aimed at radically transforming American law and legal culture. In Separate But Faithful, Amanda Hollis-Brusky and Joshua C. Wilson provide an in-depth examination of these efforts, including their causes, contours and consequences. Drawing on an impressive amount of original data from a variety of sources, they look at the conditions that gave rise to a set of distinctly "Christian Worldview" law schools and legal institutions. Further, Hollis-Brusky and Wilson analyze their institutional missions and cultural makeup and evaluate their transformative impacts on law and legal culture to date. In doing so, they find that this movement, while struggling to influence the legal and political mainstream, has succeeded in establishing a Christian conservative beacon of resistance; a separate but faithful space from which to incrementally challenge the dominant legal culture. Both a compelling narrative of the rise of Christian Right lawyers and a trenchant analysis of how institutional networks fuel the growth of social movements, Separate But Faithful challenges the dominant perspectives of the politics of law in contemporary America.***

***The first major work in English on Mathias Goeritz; (1915-1990), this book illuminates the artist's pivotal role within the landscape of twentieth-century modernism. Goeritz, became recognized as an abstract sculptor after arriving in Mexico from Germany by way of Spain in 1949. His call to integrate abstract forms into civic and religious architecture, outlined in his "Emotional Architecture" manifesto, had a transformative impact on midcentury Mexican art and design. While best known for the experimental museum El Eco and his collaborations with the architect Luis Barrag n, including the brightly colored towers of Satellite City, Goeritz also shaped the Bauhaus-inspired curriculum at Guadaluajara's School of Architecture and the iconic Cultural Program of Mexico City's 1968 Olympic Games. Josten addresses the Cold War implications of these and other initiatives that pitted Goeritz, an advocate of internationalist abstraction, against Diego Rivera and David Alfaro Siqueiros, ardent defenders of the realist style that prevailed in official Mexican art during the postrevolutionary period. Exploring Goeritz's dialogues with leading figures among the Parisian and New York avant-gardes, such as Yves Klein and Philip Johnson, Josten shows how Goeritz's approach to modernism, which was highly attuned to politics and place, formed part of a global enterprise.***
