This is the final judgment of the case involving business partners F. Schröder of Krefeld and P.A. Fonck of Köln. Schröder suspected Fonck of falsifying the account books of their wine and spirits company in order to embezzle money. Schröder hired an auditor, Wilhelm Conen, who disappeared shortly after he found accounting irregularities and was presumed murdered. Schröder filed to dissolve the partnership with Fonck. There was a criminal investigation, after Conen's disappearance, that reopened the account books but no charges were filed against Fonck at the time of this printing. Details of the exact financial settlement are included. The document is signed by "Herbertz and Schramm" in one spot and by Jörissen in four others.
