WERNICKE'S ENCEPHALOPATHY AND BIPOLAR DISORDER AT THE EMERGENCY UNIT: A CASE REPORTWernicke's encephalopathy is the presence of neurological symptoms caused by biochemical lesions of the central nervous system after exhaustion of B-vitamin reserves, in particular thiamine (vitamin B1). The prevalence is around 2%, and is considered underdiagnosed. Probably, many cases are in patients who do not have commonly-associated symptoms, as occur in patients with comorbid psychiatric diagnosis. We present a case of 57 years old man who arrived to the emergency unit because of behavior disorders. When we evaluated the patient, he had low level of consciousness. He presented myoclonus in all extremities and bilateral multidirectional nystagmus. The patient had a previous diagnosis of bipolar disorder and in recent months he had been living in a caravan in unhealthy conditions, with a diet based on water intake exclusively. Admission to the general hospital was carried out. After carrying out complementary tests, the patient had vitamin B1 deficiency as well as other vitamins such as folic acid. After resolving organic syndrome, a psychotic depression episode was diagnosed. Probably, this episode led to the state of isolation and malnutrition that the patient presented from the last weeks before arriving at the emergency unit. The coexistence of somatic and psychiatric diseases is not uncommon. As the case presented, when the symptoms are not completely clear and there are data of a certain organicity, it is important to work as a team with the rest of medical specialties ensuring an integral attention of our patients, always prioritizing the most serious pathology. One of the cardinal facets of the delivery of mental healthcare is the attention given to emergency conditions-which is the focus of this book. The manifestations of psychiatric emergencies in low- and middle-income countries may be coloured by many factors, such as culture, the social context and religious belief systems. Hence, there is a need to not only understand these, but also formulate logical and acceptable forms of intervention. This book attempts to give the reader an overview of the kinds of psychiatric emergencies that can occur and the strategies employed to manage these in developing countries. The chapters on anxiety disorders, psychotic disorders, personality disorders and substance abuse disorders describe the presentation and management of these disorders in the emergency setting. The book deals with special population groups, such as women, children and the elderly, who require different modes of intervention. The next group of chapters addresses emergencies following psychosocial and environmental events. Among the aspects covered are grief, suicidal behaviour and psychiatric emergencies following disasters. These chapters have a special significance, considering the rising rate of suicide and increase in the frequency of disasters in developing countries. The chapters on suicidal and uncooperative patients dwell on particularly challenging clinical situations, emphasizing ethical issues and the need to ensure the safety of the patient. A discussion of the medicolegal aspects of a psychiatric emergency in developing countries is of relevance since many countries still follow outdated and archaic legal procedures. As patients often present to the emergency department both with psychiatric as well as physical symptoms, a few chapters are devoted to psychiatric emergencies associated with medical disorders, sexual disorders and drug-related issues. This book aims to meet the needs of physicians, researchers and all emergency care personnel dealing with those in a state of emotional crisis. It should serve to help all types of mental health professionals in developing countries to effectively and appropriately manage the various kinds of psychiatric emergencies.

Crucial to astute clinical diagnosis is broad clinical experience. In short, you have to have seen one to recognize one! Patients with movement disorders nearly always present as outpatients but, as aptly recognized by Drs. Frucht and Fahn, this may include acute manifestations leading to emergency presentations, often in an emergency room setting, where they are very likely to be unrecognized and therefore poorly managed. The authors define an "emergency" movement disorder as one in which failure to promptly diagnose and treat may result in significant morbidity or mortality. However, they also stress the importance of certain "can't miss" diagnoses such as Wilson's disease, dopa-responsive dystonia, and Whipple's disease in which delayed diagnosis in less emergent situations can lead to slowly evolving and often irreversible neurological damage with tragic consequences.

Featuring more than 1,100 full-color illustrations, this atlas is a visual guide to the diagnosis and management of medical and surgical emergencies. Emergency medicine depends on fast, accurate interpretation of visual cues, making this atlas an invaluable tool. The book is divided into sections on prehospital management and resuscitation, organ system emergencies, and multisystem emergencies.
