One important and integral part of high-stakes English language tests is the oral proficiency interview, which can be a pre-requisite to gaining admission to an English-speaking university. The volunteer participants were 25, 15–17-year-old Emirati students from two IGCSE ESL classes that I do not teach. This study included a videotaped mock oral proficiency IGCSE interview; audiotaped semi-structured individual interviews, questionnaires, and an audiorecorded semi-structured focus group discussion. The findings suggested that language and test anxiety is multi-faceted and can affect boys and girls in a number of different ways and at different times during class activities and also in an OPI. In addition, all participants showed different physical signs of test anxiety during the first two stages of the OPI, and these physical signs of test anxiety were considerably less frequent in the final part of the OPI. The causes and types of anxiety reported by the students ranged from language learning difficulties, problems trying to retrieve appropriate English vocabulary, code switching from Arabic language to English and vice versa, differences in social status of the teachers/language instructors, and unfamiliarity with the interlocutor. The pedagogical implications of these findings for understanding anxiety and oral test anxiety with second language students for teachers, schools and examination boards are discussed, as are suggestions for future research. Furthermore, considering the important role of teachers in second language pedagogy and the use of English as the main language of instruction, this study also offers suggestions to lessen anxiety for oral class activities and oral assessments, and presents test-taking strategies.

"ESL students who take English 101 often fail the course because they fail the exit exam essay. ESL students struggle with this essay more than others in the course because it is impromptu. Impromptu essays are written in a controlled classroom setting. Students are limited as to the time they can have, three 50-minute class periods, and are limited as to the place where they write, the essay must not go home with the student at the end of the timed periods. Other essays are written without the time restraint and utilizing the process model, write and revise with peer and teacher feedback. What causes ESL students to fail the exit exam? Although there are other reasons, an area which is often the most problematic is the area of the mechanics of the language, the grammar and the punctuation. How do we as teachers help the ESL students to hone their skills and pick up speed and automaticity with mechanics so that they will be efficient enough with them to be successful with the impromptu writing of the exit exam essay? This research explores the failure rate of ESL students in English 101 due to mechanics errors and tests the effectiveness of a group of treatments designed to help ESL students to reduce mechanics errors in their papers. Errors made by ESL students during English 101 exit exams were counted. High incidences of error indicated important areas of concern to target. Next, a group of treatments to reduce errors were administered. A pre-test was given, and the number of errors made were counted. After the treatment, a post test was given and the number or errors were counted. Even though the rhetorical task at the beginning of the quarter was a relatively easier task, descriptive, than at the end of the quarter when it was more difficult, argumentation, all but one of the students showed significant reduction in the number of errors. La publicación de este volumen representa un caso relativamente insólito. Un pequeño grupo de jóvenes investigadores de menos de treinta años convence a un grupo mucho más numeroso de la misma edad para celebrar en Salamanca la First Conference of Young Researchers on Anglophone Studies. El resultado es deslumbrante. No solo demuestran una gran capacidad organizativa, sino que los resultados individuales de las aportaciones científicas son sobresalientes. Este volumen, Current Trends in Anglophone Studies, recoge una selección revisada de las propuestas presentadas en el Encuentro y gira en torno a una estructuración tripartita clásica: estudios culturales, lingüísticos y literarios. En ella caben todos aquellos que se mueven en el campo de los estudios anglófonos. Cada uno de estos campos podría haber sido suficiente para celebrar un congreso, pero parece razonable que en este tipo de encuentros tengan cabida todos. De ese modo, este volumen se convierte en un ejemplo de aproximación interdisciplinar a los estudios anglófonos. Si no pareciera demasiado atrevido, podría decirse que estos jóvenes estudiosos irían más allá de lo que un día ya lejano pudieron imaginar Richard Hoggard o Raymond Williams. Los estudios aquí presentados reflejan, sin duda, la evolución que la propia sociedad ha experimentado en estos últimos cincuenta años y exploran la relación entre las prácticas culturales, la vida diaria, y los contextos económicos, políticos e históricos. No es de extrañar que una gran parte de las contribuciones presentadas en este volumen se centren en el estudio de la lengua, ya que la demanda del inglés se ha incrementado de forma considerable en los últimos años. Sobresalen los análisis puramente filológicos y sobre todo los relacionados con el aprendizaje del inglés como segunda lengua. Por eso, destacan estudios que contemplan rasgos morfológicos, léxicos o sintácticos. The Cambridge IGCSE English as a Second Language Exam Preparation Guide: Reading and Writing provides extra guidance and practice in each of the seven examination exercises for both Core and Extended students in Papers 1 and 2 (Reading and Writing), and can be used independently, or alongside other IGCSE English as a Second Language coursebooks.
