northern Maine, Ethan Miller articulates a rich framework for engaging with the ethical and political challenges of building ecological livelihoods among diverse human and nonhuman communities. In seeking a pathway for transformative thought that is both critical and affirmative, *Reimagining Livelihoods* provides new frames of reference for living together on an increasingly volatile Earth.
