No Free Speech for Fascists explores the choice of anti-fascist protesters to demand that the opportunities for fascists to speak in public places are rescinded, as a question of history, law, and politics. It explains how the demand to no platform fascists emerged in 1970s Britain, as a limited exception to a left-wing tradition of support for free speech. The book shows how no platform was intended to be applied narrowly, only to a right-wing politics that threatened everyone else. It contrasts the rival idea of opposition to hate speech that also emerged at the same time and is now embodied in European and British anti-discrimination laws. Both no platform and hate speech reject the American First Amendment tradition of free speech, but the ways in which they reject it are different. Behind no platform is not merely a limited range of political targets but a much greater scepticism about the role of the state. The book argues

for an idea of no platform which takes on the electronic channels on which so much speech now takes place. It shows where a fascist element can be recognised within the much wider category of far-right speech. This book will be of interest to activists and to those studying and researching political history, law, free speech, the far right, and anti-fascism. It sets out a philosophy of anti-fascism for a social media age.

**By 1976, the National Front had become the fourth largest party in Britain. In a context of national decline, racism and fears that the country was collapsing into social unrest, the Front won 19 per cent of the vote in elections in Leicester and 100,000 votes in London. In response, an anti-fascist campaign was born, which combined mass action to deprive the Front of public platforms with a mass cultural movement. This book mines Australian journalism's rebelliousness, humor and distinct disrespect for authority in various socio-historical contexts, to explore its determination to maintain professional independence. Beginning with a Larrikin analysis of Australian journalism's inherited Enlightenment tradition, Dr Josie Vine takes the reader through the Colonial era's hardships, Federation, two World Wars, the Cold War's fear and suspicion, the swinging sixties, a Prime Minister's dismissal, 1980's neo-liberalism, post-9/11 and, finally, provides a conclusive synthesis of current Australian journalism culture. The Larrikin may be a uniquely Australian figure but the paradox is far from confined to Australian journalism (not least because of the influence of erstwhile Australian Rupert Murdoch on journalism in the Anglosphere), and this book should be of considerable interest to those concerned with the means whereby journalism performs its democratic, Fourth Estate role in modern democracies. If the World Wars defined the first half of the twentieth century, the sixties defined the second half, acting as the pivot on which modern times have turned. From popular music to individual liberties, the tastes and convictions of the Western world are indelibly stamped with the impact of this tumultuous decade. Framing the sixties as a period stretching from 1958 to 1974, Arthur Marwick argues that this long decade ushered in nothing less than a cultural revolution – one that raged most clearly in the United States, Britain, France, and Italy. Marwick recaptures the events and movements that shaped life as we know it: the rise of a youth subculture across the West; the sit-ins and marches of the civil rights movement; Britain's surprising rise to leadership in fashion and music; the emerging storm over Vietnam; the Paris student uprising of 1968; the growing force of feminism, and much more. For some, it was a golden age of liberation and political progress; for others, an era in which depravity was celebrated, and the secure moral and social framework subverted. The sixties was no short-term era of ecstasy and excess. On the contrary, the decade set the cultural and social agenda for the rest of the century, and left deep divisions still felt today.

This is the first history of the Hippy Trail. It records the joys and pains of budget travel to Kathmandu, India, Afghanistan and other 'points east' in the 1960s and 1970s. Written in a clear, simple style, it provides detailed analysis of the motivations and the experiences of hundreds of thousands of hippies who travelled eastwards. The book is structured around four key debates: were the travellers simply motivated by a search for drugs? Did they encounter love or sexual freedom on the road? Were they basically just tourists? Did they resemble pilgrims? It also considers how the travellers have been represented in films, novels and autobiographical accounts, and will appeal to those interested in the Trail or the 1960s counterculture, as well as students taking courses relating to the 1960s.

Jerry White's *London in the Twentieth Century*, Winner of the Wolfson Prize, is a masterful account of the city's most tumultuous century by its leading expert. In 1901 no other city matched London in size, wealth and grandeur. Yet it was also a city where poverty and disease were rife. Based on the work of Michel Foucault, this fresh and updated edition explains how a rationalization food choice - so apparent in current programmes on nutrition and health - can be traced through a genealogy of historical social imperatives and moral panics. *Food, Morals and Meaning* is essential reading for those studying nutrition, public health, sociology of health and illness and sociology of the body.

How did the concept of the secular state emerge and evolve in Australia and how has it impacted on its institutions? Social welfare reform, nationalism, and emerging conceptions of citizenship and civilization were heavily influenced by religious ideals, rendering problematic traditional linear narratives of secularisation as the decline of religion. Finally the book considers present day pluralist Australia and new understandings of state secularity in light of massive social changes over recent generations.
