The International Civil Aviation Organization's (ICAO) decision to require aviation organizations to adopt Safety Management Systems poses a major problem especially for small and medium sized aviation companies. The complexity of regulations overstrains the aviation stakeholders who seek to fully advantage from them but have no clear guidance. The aim of the book is to show the implementation of such a new system with pragmatic effort in order to gain a gradation for smaller operators. This approach should illustrate the leeway in order to adapt the processes and to show the interfaces between Corporate Risk Management and Safety Management. The book shows how to build a system with reasonable effort, appropriate to the size and complexity of the specific operator. It also gives inputs on the key aspects and how to effectively operate such a system with the various interfaces.

Furthermore, the book highlights the importance of Corporate Risk Management independent of Safety Management Systems based on

ICAO.

This book is divided into six parts, which are organized to guide the reader step by step from the macro level of the cruise industry to the micro level of operations management on board cruise ships. Part I (chapters 1-4) sets the scene for the book by characterizing the conditions under which cruise lines operate. Part II (chapters 5-8) includes four chapters that address issues of significance for corporate managers in the cruise sector. Part III (chapters 9-11) deal with aspects of the marketing mix employed by cruise lines to attract passengers and fill their ships. Part IV (chapters 12-15) is concerned with managerial functions related directly to the cruise product. Part V (chapters 16-19) focuses on operational management functions on board cruise ships. The final Part VI (chapter 20) looks at future development possibilities for the cruise sector.

Air Traffic Organization's most fundamental imperative is to ensure the safety of the national airspace system. Safety can be effectively determined not only by the current absence of accidents, but also the presence of safe conditions well into the future. Chapter 3 – Safety Risk Management: The types of changes evaluated for safety risk; processes and guidance available for determining the level of safety analysis required; detail and documentation required for safety analysis; SRM process; SRM terminology, tools, and techniques; risk acceptance requirements; tracking required NAS changes; and the development

and approval of SRM documentation. d. Chapter 4 – Safety Assurance: The importance of safety reviews and evaluations in the SMS; assurance programs, including the Air Traffic Evaluation and Auditing Program, the NAS Technical Evaluation Program, the Independent Operational Test and Evaluation process, Independent Safety Assessments, and SRM audits; importance of safety data; types of data; how data are collected and reported; processes for reporting safety incidents and accidents; relationship between incident investigations and SRM; monitoring of mitigations through safety data tracking and analysis; and existing safety data reporting documents and processes. e. Chapter 5 – Safety Promotion: What a safety culture is; why it is important; responsibilities within it; and SMS training.

The implementation of Safety Management Systems at international airports was one of the most considerable changes in the regulatory framework for the operation and licensing of aerodromes in recent years. However, even more than five years after its inception it appears that the high expectations ICAO has placed on what has been designed as paradigm shift in the way of doing business in the airport industry were not materializing and Safety Management Systems appear at best to only marginally impact the safety performance of airports. Based on the lessons learned from the implementation of SMS in Germany an ideal organizational set-up for a most effective aerodrome SMS shall be designed. This proposal of an ideal organizational set-up shall be validated through a model implementation at a representative airport and subsequent long term observation in live operation. This model implementation serves as a basis from which recommendations for a future European regulation of Aerodrome Safety Management Systems under the EASA system shall be derived.

The work is presented in the context of the literature regarding conceptual links between risk and the theoretical and operational themes of organizational learning, and in light of interviewees' comments. The themes include processes and structures of knowledge acquisition, information interpretation and distribution, organizational memory and change/adaptation and also levels of learning. The book concludes by discussing some practical implications of the research carried out in various maritime contexts and gives recommendations for the industry and other stakeholders.
