A design process usually iterates over two activities: first designing an artifact that improves something for stakeholders and subsequently empirically investigating the performance of that artifact in its context. This "validation in context" is a key feature of the book and is validated in this context. The book is divided into five parts. Part I discusses the fundamental nature of design science and its artifacts, as well as related design research questions and goals. Part II deals with the design cycle, i.e. the creation, design and validation of artifacts based on requirements and stakeholder goals. It also contains information about the rules of the game and the course of a certification audit. Cees van der Wens (1965) studied industrial automation in the Netherlands. In his role as Lead Auditor, the author has carried out dozens of ISO/IEC 27001 certification audits at a wide range of organizations. As a consultant, he has also helped many organizations obtain the ISO/IEC 27001 certificate. The author feels very connected to the standard because of the social importance of information security and the power of a management system to get better results.
