Until recently, historians of the Christian missions in the New World have seen Missionaries either as saints and martyrs or as brutal disrupters and oppressors. Both the apologists and detractors of mission enterprise have concentrated solely on the missionaries, regarding the native populations either as childlike beneficiaries or as mutely suffering victims. With the growth of ethnobiology as a field of research, new research has sought to reconstruct the situations, the reactions, and the strategies of native groups, thereby seeing the native peoples of the Americas as active agents in their own history. In Mission Culture on the Upper Amazon, David Block describes the formation of a new society in the Moxos region of the Amazon Basin, in what is now northern, or lowland, Bolivia. This society began with the arrival of the Jesuits in the region. The mutual synthesis that became Jesuit mission culture followed, with Moxos Indian cultural survival and adaptation continuing after the expulsion of the Jesuits in 1767. With the cataclysmic onset of the rubber boom, the entire region was plunged into a period of severe exploitation and conflict that persists to this day. Block’s nuanced treatment of the mission encounter—one extending over a large time period—permits a balanced understanding of the mission enterprise, native response, and the cultural synthesis that ensued.

Plasma is the physical state in which most of the visible matter in the universe is found. Warfare in the twenty-first century goes well beyond conventional armies and nation-states. In a world of diffuse conflicts taking place across sprawling cities, war has become fragmented and uneven to match its settings. Yet the analysis of failed states, civil war, and state building rarely considers the city, rather than the country, as the terrain of battle. In Cities at War, Mary Kaldor and Saskia Sassen assemble an international team of scholars to examine cities as sites of contemporary warfare and insecurity. Through a series of case studies of cities including Baghdad, Bogotá, Ciudad Juarez, Kabul, and Karachi, the book reveals the unequal distribution of insecurity as well as how urban capabilities might offer resistance and hope. Through analyses of how contemporary forms of identity, inequality, and segregation interact with the built environment, Cities at War explains why and how political violence has become increasingly urbanized. It also points toward the capacity of the city to shape a different kind of urban subjectivity that can serve as a foundation for a more peaceful and equitable future. A first installment in a new series written by a 13-year-old author follows the experiences of young Jake, who endures the drama and frustrations of being the new kid in school.

Seaquake. It was the most dreaded of all undersea phenomena. If strong enough, it would set up chain-reaction pressures that could shatter any dome and cost inestimable lives. But the Krakatoan Dome has been specifically designed to cope with the tremors of its seaquake-prone area. The trouble was, all of a sudden, there were more quakes than any of the experts had counted on... quakes that no one could possibly have forecast because they hadn't come from natural causes. The Sub-Sea Academy had assigned Cadet Jim Eden to the Krakatoan Dome to find out what was going on, and for very special reasons. First, he was more at home in the underwater world than almost anyone else. But, even more important, they sent Jim because his Uncle was suspected of being the heinous saboteur!

It is the spring of 1939 in the age of anxiety. In months Europe will be Hitler's. And Badenheim, a resort town vaguely in the orbit of Vienna, is preparing for its summer season. The vacationers arrive as they always have, a sampling of Jewish middleclass life: the impresario Dr. Pappenheim, his musicians, and their conductor; the gay Frau Tsauberblit; the historian Dr. Fussholdt and his much younger wife; the 'readers, ' twins whose passion for Rilke is featured on their program; a child prodigy; a commercial traveler; a rabbi. The list waxes as the summer wanes. To receive them in the town are the pharmacist and his worried wife, the hotelier and his large staff, the pastry shop owner and his irritable baker, Sally and Gertie (two quite respectable prostitutes), and, mysteriously, the bland inspectors from the "Sanitation Department." The story unfolds as matter-of-factly as a Chekhov play. The characters on stage are so deeply held by their defensive daily trivia that they manage to misconstrue every signal of their fate. Finally, de facto prisoners in their familiar resort, the vacationers, now increased by the forced crowding-in of other Jews hardly on vacation, take on the lineaments of undefined disaster. The text builds a sense of foreboding in which each human detail is so persuasive, so right in its fidelity to the terrible evasions of the time, that it leaves the reader transformed by what he and the author know must happen to Badenheim's people. Badenheim 1939 owes everything to its author's astonishing capacity to recreate the energies and confusions of innocent and uncomprehending victims who, always loyal to civility and social graces, fail to even dimly see thecruel terms of their imminent fate.

Violence is one of the most important challenges, not only for public health systems, but also for public mental health. The authors, from different fields of expertise, facilitate interdisciplinary and international insights into the impact of violence on mental health.

Hans Roth was a member of the anti-tank panzerjager battalion, 299th Infantry Division, attached to the Sixth Army, as the invasion of Russia began. As events transpired, he recorded the tension as the Germans deployed on the Soviet frontier in June 1941. Then, a firestorm broke loose as the Wehrmacht tore across the front, forging into the primitive vastness of the East. During the Kiev encirclement, Roth’s unit was under constant attack as the Soviets desperately tried to break through the German ring. At one point, after the enemy had finally been beaten, a friend serving with the SS led him to a site—possibly Babi Yar—where he witnessed civilians being massacred. After suffering through a brutal winter against apparently endless Russian reserves, his division went on the offensive again when the Germans drove toward Stalingrad. In these journals, attacks and counterattacks are described in you-are-there detail. Roth wrote privately, as if to keep himself sane, knowing his honest accounts of the horrors in the East could never pass Wehrmacht censors. When the Soviet counteroffensive of winter 1942 begins, his unit is stationed alongside the Italian 8th Army, and his observations of its collapse, as opposed to the reaction of the German troops sent to stiffen its front, are of special fascination. Roth’s three journals were discovered many years after his disappearance, tucked away in the home of his brother. After his brother’s death, his family discovered them and sent them to Rosel, Roth’s wife. In time, Rosel handed down the journals to Erika, Roth’s only daughter, who had emigrated to America. Roth was likely working on a fourth journal before he was reported missing

in action in July 1944. Although his ultimate fate remains unknown, what he did leave behind, now finally revealed, is an incredible firsthand account of the horrific war the Germans waged in Russia.

This book addresses sixteen different reform proposals that are urgently needed to correct the fault lines in the international tax system as it exists today, and which deprive both developing and developed countries of critical tax resources.
