New Frontiers of Relational Thinking in Psychoanalysis aims to take the reader into the depths of their humanity, to promote a creative process that the author calls 'consistency'. Consistency is a quality that enables human subjects to make themselves the starting point of their life, whatever this may be. This book offers a thorough exploration of the place of relational thinking in contemporary psychoanalytic theory and practice.

Starting with an analysis of the social and cultural context in which psychoanalysis is currently operating, and of the fragility of the human subject, the author continues by examining the essential assumptions, theoretical strands and key concepts, such as 'consciousness of consciousness', and the I subject, which helps underpin psychoanalysis. New Frontiers of Relational Thinking in Psychoanalysis develops theoretical and clinical ideas through a review of classic references, in light of new scientific and sociological perspectives, to explore and promote the progress of human beings towards their 'consistency'. This book will be of great interest to anyone wanting to understand the place of relational thinking in psychoanalysis now, and how it is likely to develop in the near future, attentive to the challenges of society. It will also be of great value to psychoanalysts, psychologists and other mental health professionals, both in practice and in training.

**The theme of suicide was of paramount importance in Italy in the long nineteenth century, from the French revolution to the outbreak of World War I. A number of writers, intellectuals, politicians, and artists wrote about suicide, and a very high number of people killed themselves, for several reasons. There were suicides for love and for homeland, suicides for despair, and suicides for ennui. In Italy, once a very traditional, Catholic country, where suicide was very uncommon and rarely treated as a subject of moral theology or literature, it suddenly became extremely widespread. Its authors rank among the best international specialists on suicide, and the figures dealt with include major intellectuals and writers such as Ugo Foscolo, Emilio Salgari, Giuseppe Pellizza da Volpedo, Giacomo Leopardi and Carlo Michelstaedter.**

After the introduction by Michel Balard, the first papers examine aspects of crusader terminology.
