Transnational computer crime, particularly Internet fraud, identity theft cartels, and global black marketeering of stolen and counterfeit goods, are entrepreneurial crime problems that are increasingly being relegated to SLTLE agencies to investigate simply because of the volume of criminal incidents. Similarly, local law enforcement is being increasingly drawn into human trafficking and illegal immigration enterprises and the often associated crimes related to counterfeiting of official documents, such as passports, visas, driver's licenses, Social Security cards, and credit cards. All require an intelligence capacity for SLTLE, as does the continuation of historical organized crime activities such as auto theft, cargo theft, and virtually any other scheme that can produce profit for an organized criminal entity. To be effective, the law enforcement community must interpret intelligence-related language in a consistent manner. In addition, common standards, policies, and practices will help expedite intelligence sharing while at the same time protecting the privacy of citizens and preserving hard-won community policing relationships.~***

Trajan (AD 98-117) is one of the very few Roman emperors who has always been seen in a good light. Popular during his lifetime, by the fourth century he had become the litmus test of imperial excellence. In the Middle Ages he was placed by Dante in the sixth sphere of Heaven among the Just and Temperate Rulers, and for Gibbon, Trajan's principate ushered in the Golden Age of the Roman Empire. This manual is focused on establishing the framework of PIO, how PIO supports military police and Army operations, and how to integrate PIO within the other four military police functions: Law and order (L&O), internment and resettlement (I/R), maneuver and mobility support (MMS), and area security (AS).
