In the era of "big data," science is increasingly information driven, and the potential for computers to store, manage, and integrate massive amounts of data has given rise to such new disciplinary fields as biomedical informatics. Applied ontology offers a strategy for the organization of scientific information in computer-tractable form, drawing on concepts not only from computer and information science but also from linguistics, logic, and philosophy. This book provides an introduction to the field of applied ontology that is of particular relevance to biomedicine, covering theoretical components of ontologies,

best practices for ontology design, and examples of biomedical ontologies in use. After defining an ontology as a representation of the types of entities in a given domain, the book distinguishes between different kinds of ontologies and taxonomies, and shows how applied ontology draws on more traditional ideas from metaphysics. It presents the core features of the Basic Formal Ontology (BFO), now used by over one hundred ontology projects around the world, and offers examples of domain ontologies that utilize BFO. The book also describes Web Ontology Language (OWL), a common framework for Semantic Web technologies. Throughout, the book provides concrete recommendations for the design and construction of domain ontologies.

For decades, the world's governments have struggled to move from talk to action on climate. In this book Grundmann argues that Marx's theory of human nature and his evolutionary thinking are cogent tools for understanding basic traits of industrial countries and the ecological problems they produce. He challenges the widespread belief that the development of productive forces is by itself a threat to the environment, arguing that only specific technologies, not technology as such, lead to environmental degradation. He concludes that the pursuit of productivity and the development of a healthy environment need not be mutually exclusive.
