Evidence in support of the theories concerning translation universals is also found and their implications for EU legal translation are discussed. The results lead to the formulation of several hypotheses as regards the norms governing the translation of EU legislative texts. The book also reflects on the impact that the translational choices have on the development of European Union legal language as an independent variety. However it covers the law needed for A level (AQA, OCR, Eduqas and Cambridge International 2017 specifications) and other law courses. Börzel argues that political controversy combined with voting power and administrative capacity, explains why noncompliance with EU law has been declining since the completion of the Single Market, cannot be blamed on the EU's Central and Eastern European member states, and is concentrated in areas where EU seeks to protect citizen rights.
