Why yet another book on antennas? The aim of the authors was to offer a didactic text appropriate for advanced graduate students, as well as a practical work for practicing engineers; to combine a solid theoretical treatment with a practical development which should allow the serious reader to undertake antenna design from first principles. To accomplish these goals, the authors bring together their contributions from both industry and the academic environment. The developments of the various topics start at a level which is accessible to a novice in the speciality, but give a treatment which culminates at an advanced level. Another important feature of the book is its use of practical examples illustrating real engineering problems and designs. In most cases, the explanation is sufficient to grasp the principles of operation of the related equipment, and, where appropriate, the reader is referred to a relevant bibliography for more complete and hence more sophisticated methodologies of design. Of particular note are the chapters on specialist subjects such as antennas and signal theory, and signal processing antennas, showing how the antenna may be combined with signal processing techniques in imaging applications, in angular superresolution, and in adaptive arrays to suppress interference and jamming. Another example is the chapter on the use of polarimetry to enhance the wealth of information which may be extracted, for example, from radar signals.

The book will address the state-of-the-art in integrated circuit design in the context of emerging systems. New exciting opportunities in body area networks, wireless communications, data networking, and optical imaging are discussed. Emerging materials that can take system performance beyond standard CMOS, like Silicon on Insulator (SOI), Silicon Germanium (SiGe), and Indium Phosphide (InP) are explored. Three-dimensional (3-D) CMOS integration and co-integration with sensor technology are described as well. The book is a must for anyone serious about circuit design for future technologies. A fundamental rule of logic is that in order to make an argument to provide good reasons for its conclusion, the premises of the argument must be true. In this book, Collin Rice shows how the practice of science repeatedly, pervasively, and deliberately violates this principle. Rice argues that scientists strategically use distortions that misrepresent relevant features of natural phenomena in order to explain and understand--and that they use these distortions deliberately and justifiably in order to discover truths that would be otherwise inaccessible. Contrary to the standard emphasis on causation, accurate representation, and decomposition of science into accurate and inaccurate parts, Rice shows that science's epistemic achievements can still be made possible despite their being produced through the use of holistically distorted scientific representations. As he argues, this distortion is one of the most widely employed and fruitful tools used in scientific theorizing. Marshalling a range of case studies, Rice contends that many explanations in science are noncausal, and he presents an alternate view of explanation that captures the variety of noncausal explanations found across the sciences. He proposes an alternative holistic distortion view of scientific models, connecting it to physicists' concept of a universality class; shows how universality classes can overcome some of the challenges of multiscale modeling; and offers accounts of explanation, idealization, modeling, and understanding.

The text can be used for a microeconometrics course, typically a second-year economics PhD course; for data-oriented applied microeconometrics field courses; and as a reference work for graduate students and applied researchers who wish to fill in gaps in their toolkit. Distinguishing features of the book include emphasis on nonlinear models and robust inference, simulation-based estimation, and problems of complex survey data. The book makes frequent use of numerical examples based on generated data to illustrate the key models and methods. More substantially, it systematically integrates into the text empirical illustrations based on seven large and exceptionally rich data sets.

This book covers the principles of operation of electromagnetic waveguides and transmission lines. The approach is divided between mathematical descriptions of basic behaviors and treatment of specific types of waveguide structures. Classical (distributed-network) transmission lines, their basic properties, their connection to lumped-element networks, and the distortion of pulses are discussed followed by a full field analysis of waveguide modes. Modes of specific kinds of waveguides - traditional hollow metallic waveguides, dielectric (including optical) waveguides, etc. are discussed. Problems of excitation and scattering of waveguide modes are addressed, followed by discussion of real systems and performance.

Building on the success of the previous three editions, Foundations for Microstrip Circuit Design offers extensive new, updated and revised material based upon the latest research. Since its beginnings with Fourier (and as far back as the Babylonian astronomers), harmonic analysis has been developed with the goal of unraveling the mysteries of the physical world of quasars, brain tumors, and so forth, as well as the mysteries of the nonphysical, but no less concrete, world of prime numbers, diophantine equations, and zeta functions. Quoting Courant and Hilbert, in the preface to the first German edition of Methods of Mathematical Physics: "Recent trends and fashions have, however, weakened the connection between mathematics and physics." Such trends are still in evidence, harmful though they may be. My main motivation in writing these notes has been a desire to counteract this tendency towards specialization and describe applications of harmonic analysis in such diverse areas as number theory (which happens to be my specialty), statistics, medicine, geophysics, and quantum physics. I remember being quite surprised to learn that the subject is useful. My graduate education was that of the 1960s. The standard mathematics graduate course proceeded from Definition 1. 1. 1 to Corollary 14. 5. 59, with no room in between for applications, motivation, history, or references to related work. My aim has been to write a set of notes for a very different sort of course.

Thus, these devices provide the crucial building blocks in common microwave systems, and their inherent characteristics are also the basis of some of the fundamental concepts in more complex devices. Microwave testing has been paid only scant attention in the literature as a method for nondestructive testing of materials, yet it offers some attractive features, especially for the testing of composite and other non-metallic materials. Microwave techniques have been used in a large number of applications that can be classified as nondestructive testing applications, ranging from large scale remote sensing to detection of tumors in the body. This volume describes a unified approach to microwave nondestructive testing by presenting the three essential components of testing: theory, practice, and modelling. While recognizing that each of these subjects is wide enough to justify a volume of its own, the presentation of the three topics together shows that these are interrelated and should be practiced together. While few will argue against a good theoretical background, modelling and simulation of the testing environment is seldom part of the NDT training in any method, but particularly so in microwave testing. The text is divided in four parts. The first part presents the field theory background necessary for understanding the microwave domain. The second part treats microwave measurements as well as devices and sources and the third part discusses practical tests applicable to a variety of materials and geometries. The fourth part discusses modelling of microwave testing. Each chapter contains a bibliography intended to expand on the material given and, in particular, to point to subjects which could not be covered either as not appropriate or for lack of space.
