In other words, organizational behavior is the psychology of organizations and organizational theory is the sociology of organizations (Daft, 2004)"--

Building theories of organizations is challenging: theories are partial and "fuzzy" categories are fuzzy. The commonly used tools—first-order logic and its foundational set theory—are ill-suited for handling these complications. Here, three leading authorities rethink organization theory.
