World War II remains the defining experience for the U.S. Army in the twentieth century. It has had a lasting impact on the nation and its place in the world and on the Army and the way it organizes and fights. Although historians have written numerous volumes concerning this global conflict, some gap in the literature remain. In particular, the subject of an American field army headquarters and its organization and role have attracted little attention. Studies on the personalities and styles of individual commanders exist, but the command posts themselves-the ways in they were structures and operated and the functions they performed-have not been much explored. With A Command Post at War: First Army Headquarters in Europe, 1943-1945, the Center of Military History attempts to redress this shortcoming. This study addresses the First Army headquarters in the European theater from its activation in October 1943 to V-E Day in May 1945. Under Generals Omar N. Bradley and Courtney H. Hodges, the First Army headquarters oversaw the American landings on D-Day, the breakout from the Normandy beachhead, the battle of Hirtgen Forest along the German frontier, the defense of the northern shoulder during the Battle of the Bulge, and the crossing of the Rhine River at Remagen prior to the final American drive into central Germany. In examining the First Army headquarters' role, this volume shows the army headquarters of World War II as a complicated organization with functions ranging from the immediate supervision of tactical operations to long-range operational planning and the sustained support of frontline units. The commander and staff faced the problem of coordination with Allied counterpartsas well as with headquarters and units from other services. Inadequate information and the limitations of technology added to their challenges. The human dimension was always important, and at times critical, in affecting the work of the headquarters under the stresses of a difficult campaign against an obstinate and resourceful foe. Although times have changed and the modern Army focuses more on regional conflicts and contingencies than on global warfare, we can still learn much from the experience of the First Army headquarters. The Gulf War reemphasized the role of an army headquarters in a theater of operations as a pertinent issue for today's military professional. By examining the experience of soldiers in past conflicts we gain the deeper perspectives and understandings necessary to meet the challenges facing the Army today and in the future. This regulation covers policy and procedures for assigning, attaching, removing, and transferring U.S. Army Reserve soldiers. It defines Ready Reserve Control Groups and the Selected Reserve. Detailed procedures are given for removing soldiers from an active status. It also gives procedures for interservice transfer and selective retention of unit soldiers.

The term "Reserve Component" is used to refer collectively to the seven individual reserve components of the armed forces: the Army Nat. Guard (NG), the Army Reserve, the Navy Reserve, the Marine Corps Reserve, the Air NG, the Air Force Reserve, and the Coast Guard Reserve. These reserve components provide trained units and qualified persons available for active duty in the armed forces. Since 1990, reservists have been involuntarily activated six times, incl. two large-scale mobilizations for the Persian Gulf War and in the aftermath of 9/11. This increasing use of the reserves has led to interest in funding, equipment, and personnel policy. This report provides an overview of key reserve component personnel issues. More than forty nations provided assistance to the Republic of Vietnam in its struggle against North Vietnam. This aid ranged from economic and technical assistance to educational and humanitarian contributions. Hundreds of Free World civilians worked in Vietnam as doctors, teachers, and technical specialists. Eight nations also provided military assistance. The flags of these Free World countries-the United States, the Republic of Korea, Thailand, Australia, New Zealand, the Philippines, the Republic of China, and Spain-flew alongside the colors of the Republic of Vietnam at the headquarters of the Free World Military Assistance Forces in Saigon. The military contributions of these nations included combat troops, army medical teams, and individual political warfare advisers. The degree of assistance and co-operation among the concerned Free World nations resulted from years of work and involvement. While many nations expressed sympathy for the plight of South Vietnam, aid did not always come easily, quickly, or to the extent desired. Many nations, beset by their own internal economic and political problems, could do little to help; others did nothing. The story of the efforts of the contributing nations and the efforts to enlist their aid is the subject of this monograph.

(Includes maps) From September 1943, when Allied troops came ashore near Salerno, until German surrender in May 1945, 312,000 Allied soldiers were killed, wounded, or missing in Italy. Was a campaign that from the first faced the bleak prospect of coming to a dead end against the forbidding escarpment of the Alps worth that cost? Was the objective of tying down German troops to avoid their commitment in northwestern Europe all that the campaign might have accomplished? The answers to those questions have long been sought but, as is the nature of history, must forever remain conjecture. What is established bet, as this volume makes clear, is the tenacity and intrepidity displayed by American and Allied soldiers in the face of a determined and resourceful enemy, harsh weather, sharply convoluted terrain, limited numbers, and indefinite goals in what many of them must have looked upon as a backwater of the war. This regulation encompasses garrison, field, and subsistence supply operations. Specifically, this regulation comprises Army Staff and major Army command responsibilities and includes responsibilities for the Installation Management Command and subordinate regions. It also establishes policy for the adoption of an à la carte dining facility and for watercraft to provide subsistence when underway or in dock. Additionally, the regulation identifies DOD 7000.14-R as the source of meal rates for reimbursement purposes; delegates the approval authority for catered meals and host nation meals from Headquarters, Department of the Army to the Army commands; and authorizes the use of the Government purchase card for subsistence purchases when in the best interest of the Government. This regulation allows prime vendors as the source of garrison supply and pricing and provides garrison menu standards in accordance with The Surgeon General's nutrition standards for feeding military personnel. Also, included is guidance for the implementation of the U.S. Department of Agriculture Food Recovery Program.
