"Every year between 250 000 and 500 000 people suffer a spinal cord injury, with road traffic crashes, falls and violence as the three leading causes. People with spinal cord injury are two to five times more likely to die prematurely. They also have lower rates of school enrollment and economic participation than people without such injuries. Spinal cord injury has costly consequences for the individual and society, but it is preventable, survivable and need not preclude good health and social inclusion. Prevention and Treatment emphasizes the vital role of the clinician in prevention efforts, including a prevention strategy tailored specifically for adolescents and young adults; discusses a variety of behavioral and pharmacological interventions for patients including self-help and professional-based interventions for family members; and concludes with assessments useful in diagnosing pathological gambling and monitoring symptom change. The main purpose of this book is to address some important issues related to gynecologic laparoscopy. While the civil rights movement has put disability issues centre-stage, there has been minimal discussion of disabled people's sexuality. This book, based on first-hand accounts, takes a close look at questions of identity, relationships, sex, love, parenting and abuse and demolishes the taboo around disability and sex. It shows the barriers to disabled people's sexual rights and sexual expression, and also the ways in which these obstacles are being challenged. Various moving, angry, funny and proud, The Sexual Politics of Disability is about disabled people sharing their stories and claiming their place as sexual beings. It is a pioneering work, and essential reading for anyone interested in disability or sexual politics.

The innovative program described in this book revolutionizes the treatment of sexual dysfunction. During eleven years of daily clinical work, more than five hundred couples have been treated at Masters and Johnson's Reproductive Biology Research Foundation in St. Louis. Here the relationship itself is the patient. The authors stress that there is no uninvolved partner when sex is a problem. Therefore they treat the partners even if only one appears to be sexually dysfunctional. And their therapy techniques have proven successful in 80 percent of all cases treated. The key to this unprecedented record is the role of the dual therapy team. Masters and Johnson have found that it takes both a man and a woman therapist to treat a couple effectively. The dual therapy team acts as a catalyst, encouraging communication between partners when none has existed before. They use psychological and psychological methods of treating impotence, ejaculatory incompetence, premature ejaculation, orgasmic dysfunction in women, vaginismus, and painful intercourse. Basic to all treatment techniques is the premise that attitudes and ignorance rather than any mental or physical illness are responsible for most sexual problems. The two-week rapid therapy program developed by Masters and Johnson includes both counseling and specific instructions for patients to follow in privacy. All results of success or failure reported in Human Sexual Inadequacy Are substantiated by a unique five-year patient follow up program. The concept and format of the therapy program are examined in detail in the first two chapters of the book. Included are discussions of the qualifications for co-therapists and accounts of history-taking techniques and round table talks held by the co-therapists and the couple. A full description follows of the instructions given by the therapists to effect psychosexual reorientation of the marital problems. Analysis of each type of dysfunction, its progression and manifestations, accompanies the important step-by-step explanation of practical treatment methods. Chapters on sexual function and dysfunction of the geriatric population explain how the aging male and female can function sexually even in their eighties if they learn to adjust their sexual activities to the natural changes of aging. Program statistics and a critical review of treatment failures conclude this landmark book. Masters and Johnson estimate that one-half of the marriages in the United States are threatened by sexual dysfunction. The therapy program described in HUMAN SEXUAL INADEQUACY introduces a new era in the effective treatment of these sexual difficulties that prevent the enjoyment of a full sex life and a happy marriage. The exceptionally clear account of their major breakthrough in therapy is a long-needed and invaluable guide to clinical counseling and treatment. In addition, it provides an excellent basis for training programs for professional therapists. The Language of the Body, originally published as **Physical Dynamics of Character Structure**, brilliantly describes how personality is expressed in the form and function of the body. The body is the key to understanding behavior and working with the body is the key to psychological health. The Language of the Body outlines the foundations of character structure: schizoid, oral, masochistic, hysteric, and phallic narcissistic personality types. Dr. Lowen examines the relationship between psychoanalytic theory and body therapy.

Sexual mutilation is a global problem that affects 15. 3 million children and young adults annually. In terms of gender, 13. 3 million boys and 2 million girls are involuntarily subjected to sexual mutilation every year. While it is tempting to quantify and compare the amount of tissue removed from either gender, no ethical justification can be made for removing any amount of flesh from the body of another person. The violation of human rights implicit in sexual mutilation is identical for any gender. The violation occurs with the first cut into another person 's body. Although mutilation is a strong term, it precisely and accurately describes a condition denoting "any disfigurement or injury by removal or destruction of any conspicuous or essential part of the body. " While such terms as "circumcision" and "genital cutting" are less threatening to our sensitivities, they ultimately do a disservice by masking the fact of what is actually being done to babies and children. Although the courageous example of the survivors of sexual mutilation indicates that humans can certainly live and even re produce without all of their external sexualorgans, this biological phenomenon does not, however, justify subjecting a person to sexual mutilation. The remarkable resilience of the human body is a testament to the importance nature places on reproduction rather than a vindication for surgical practices that compromise this function.

o history of endocrinology can be written without reference N to Sir Humphry Davy Rolleston, whose monumental study of the subject appeared in 1936 under the modest subtitle: The Endocrine Organs in Health and Disease with an Historical Review. It was based on the author's Fitzpatrick Lectures at the Royal College of Physicians of London in 1933 and 1934. The lectureship, which dates from 1901, is devoted to the History of Medicine. Rolleston's work as regards scholarship and delivery cannot be surpassed and will remain the solid basis for any further study. It is of interest to note that Rolleston gave the Fitzpatrick Lectures when he was 71 years of age and had his book published when he was 74. By that time he had achieved most of his professional aims and all the honours a distinguished medical career can offer (see Section II). He perceived clearly that endocrinology was "an enormous subject in a most active stage of growth", which "recently has received most valuable help from organic chemists, who have devoted much time to the elucidation of the structure, isolation and synthesis of the hormones". He remarked that the knowledge of endocrinology was expanding with extreme rapidity, and it has been suggested that in this respect it would appear to be itself influenced by a growth hormone. He continued: "Before 1890 there were comparatively few publications dealing with the ductless glands, but in 1913, A.
